All these seats will be surrendered to the respective colleges and will be filled up at the Institutional level, as per provision in the clause No.14 of Maharashtra Unaided Private Professional Educational Institutions Rule, 2016. **Students taking admission after 31st Oct. 2018, will not be granted that term by MUHS.**

3	Publication of Merit List, Selection List , Wait list on Notice Board and Website of respective Institute.	14-11-2018 at 10.00 am
4	Selected candidate report to respective Institute with all original documents and requisite fees for admission.	15-11-2018 upto 01.00 pm
5	Display of vacant seats as on at 01.00 pm on Notice Board	15-11-2018 at 01.30 pm
6	Wait listed candidates from the Merit list to report the respective Institute for admission against vacancy (if any)	15-11-2018 from 03.30 pm to 05.30 pm
7	The concerned Institute should submit the details of admitted students by email to maharashtra.cetcell@gmail.com and directorayurvedmaha@gmail.com as well as online portal at www.dmer.org	15-11-2018 upto 08.00 pm

Eligibility for Institutional Round admission process

- 1) Candidates who have appeared in AIA-PGET 2018 Exam and fulfilling eligibility criteria and have registered on www.mahayush.gov.in and/or www.mahacet.org for PG Homoeopathy admissions in Maharashtra.
- 2) Candidate must possess all original documents mentioned in the AIA-PGET-(Hom)2018 Brochure at Rule No.8.3.
- 3) All such candidates who are not admitted / who have cancelled admission on or before 11th November, 2018.

Candidates not eligible for Institutional Round admission process

- 1) Candidates having joined status in Private college on 11th November 2018 at 05.00 pm.
- 2) Those candidates who do not possess all original documents at the time of Institutional Round are not eligible.

Procedure for Institutional Round

- 1) Institutional Round is for Private colleges PG courses for seats remaining vacant after all Central computerised rounds and Personal Counselling Round.
- 2) For Institutional Round eligible and interested candidates should apply in prescribed format downloaded from the websites **www.mahacet.org** and **www.mahayush.gov.in** to the Principal of the respective colleges within prescribed time and submit application in person.
- 3) At the time of admission, Candidate should submit all original documents and requisite fees in prescribed time, no extra time will be given.
- 4) The candidates will not be granted admission on the basis of Bonafide / Holding certificate. It is the sole responsibility of candidate to submit all the requisite documents at the time of admission.
