Smt. Malini Kishore Sanghavi Homoeopathic Medical Centre, Sumeru Navkar Tirth, Miyagam, Dist- Baroda has applied for establishment of Homoeopathic College to run BHMS Courses at Sumeru Navkar Tirth, Miyagam, Dist- Baroda, on careful consideration of the proposal, the Government of Gujarat has decided to issue "NO Objection Certificate to the applicant for the establishment of Homoeopathic College with intake capacity of 50 seats.

It is certified that:-

- (a) the applicant owns and manages of 50 bedded hospital, which was established in the year 2006.
- (b) it is desirable to establish Homoeopathy College in the public interest starting BHMS course and
- (c) establishment of BHMS course at Smt. Malini Kishore Sanghavi Homoeopathic Medical Centre, Sumeru Navkar Tirth, Miyagam, Dist- Baroda by Dr. M.L. Dhawale Memorial Homoeopathic Institute is feasible.

The desired " No Objection Certificate" in respect of following facts is being issued:-

- (1) There are 15 Homoeopathic Medical College already existing in the state.

- (2) There are 1475 seats available in these Homoeopathic Medical Colleges.
- (3) There are 6687 Homoeopathic practitioners registered with the State Council.
- (4) There are 218 Homoeopathic practitioners in the State Government.
- (5) There are 16 vacant posts in the State Government.
- (6) There are 40 Homoeopathic (B.H.M.S) and 40 (D.H.M.S.) doctors registered with the State Employment Exchanges.
- (7) Homoeopathic Doctors and population ratio in the state is 1:8000
- (8) Establishment of BHMS Course would solve the problems of qualified Homoeopathic Medical personnel in the state and across the country.
- (9) There is no restriction imposed by state Govt. for admitting students for BHMS course of outside of Gujarat State.
- (10) This NOC is issued subject to (a) Admission procedure and Fee fixation supervision to be done by Hon. Justice R.J. Shah Committee (b) College requires to get permission of Department of AYUSH, Ministry of Health & Family Welfare, Govt. of India before admitting the students (c) College requires to full fill the norms/ minimum standard prescribed by the Central Council of Homoeopathy, New Delhi from time to time (d) This NOC is issued for running the course on Self Finance basis and college will not ask for Grant-in-Aid in future.
- (11) This NOC is issued for intake capacity of 50 seats at 1st BHMS to Smt. Malini Kishore Sanghavi Homoeopathic Medical Centre, Sumeru Navkar Tirth, Miyagam, Dist- Baroda run by Dr. M.L. Dhawale Memorial Homoeopathic Institute.
- (12) College has all facilities to run BHMS course and possess all infrastructure facilities prescribed by CCH, New Delhi moreover, there is a need of qualified Homoeopathic Medical personnel to strengthen the Health Services. Therefore, there is a need of establishment of Homoeopathic College in the State.
